## TERMS AND CONDITIONS

### WELCOME TO ALBERTA BET!

This agreement describes the terms and conditions applicable to the use of this pari-mutuel account established between yourself and Rocky Mountain Turf Club (RMTC). (Further reference to RMTC may be referred to as "we", "us", "our") and (Telephone Account Wagering as "TAB")

### QUALIFICATIONS

To qualify, you must confirm with picture ID that you are 18 years of age or older, and reside in the Alberta market area. The market area for RMTC, is approved by Horse Racing Alberta (HRA).

Should our local racing association not be able to conduct account wagering for our clients, RMTC will seek approval from CPMA for the right to continue account wagering for Online and TAB.

Applications for accounts and credit card transfers are available online, in person at the RMTC information kiosk located at Elbow River Casino Calgary, Lethbridge race track, and by fax.

### ACCOUNT HOLDER RESPONSIBILITIES

This account is for your personal use only. Any wagers placed by a person other than yourself is strictly prohibited and will result in the immediate termination of your account. You bear full responsibility for maintaining the confidentiality of your account number and password. You are legally responsible for all wagering placed through your account using your account number and password, whether done by you or another person without your knowledge or consent, until RMTC has been notified for the cancellation of your account.

### CONDITIONS

Winnings are instantly credited into your account following confirmation of the final result.

Should funds be credited to an account erroneously, it is your responsibility to notify RMTC and pay back the said funds without delay. RMTC reserves the right to adjust the said account if funds are available.

Any miscalculations or adjustments from any race course shall be re-calculated to and from your account as per the Canadian Pari-Mutuel Agency Rules and Regulations.

If for any reason it becomes impossible to successfully merge any wagers into the common pool, your original wager(s) shall be refunded back into your account.

### CANCELLATIONS OF WAGERS

Every effort will be made to process the cancellation of any ticket, however, we cannot guarantee cancellations close to post time. Any TAB cancellations over \$300 will need approval by the governing body to ensure that the cancellation of the bets does not negatively impact the integrity of betting.

### DEPOSITS

Deposits can be made in person using your account card at any self-serve terminals in Lethbridge or at our Off Track Betting (OTB) locations. As well as in person at the RMTC kiosk and Lethbridge RaceTrack. Credit card deposits are also available if you have preregistered one or more credit cards with RMTC. Cash Deposits are only available with lead tellers at OTB locations.

Money orders and certified cheques along with your name and account number are also accepted and mailed to: TAB Office, 3401 Parkside Dr. S, Lethbridge, AB T1K 6X5

Monies on deposit in your account will not bear any interest to you.

### WITHDRAWALS

Withdrawals can be made in person using your account card at any self-serve terminal at our OTB's by printing a voucher from your account, as well as in person at the Lethbridge race track or RMTC kiosk.

Withdrawals exceeding \$1000 may not be honored at all OTB locations. To redeem withdrawals in excess please visit the Lethbridge race track, or RMTC kiosk.

Large withdrawals may take between 2-5 business to process .

We cannot transfer funds to Credit Cards or banks.

All withdrawals in person require photo identification.

### CLAIMS

Account statements will be provided upon written or personal request.

Any claims by the account holder that his or her statement is incorrect when betting through TAB should be made within 10 days of the transaction.

When a dispute arises, the tape recorded transaction data that was restated back to the account holder and acknowledged by you, shall be considered the actual bet.

On line wagering is the responsibility of the individual.

### ACCOUNT CLOSURES

We reserve the sole and exclusive right to close your account for any reason whatsoever, by returning the balance of any funds in your account to you along with a closing Account Statement.

### INDEMNIFICATION

You agree to indemnify and hold harmless Alberta Bet, suppliers, distributors, local horse racing associations, and it's affiliates and their respected directors and employees from all claims, liabilities and costs (included but not limited to reasonable attorneys fees and court costs), losses or damages whatsoever incurred, arising out of or relating to your breach of these Terms and Conditions.

We reserve the right to make changes to these terms and conditions at any time and from time to time, with any such changes taking effect immediately upon notice to you of the relevant changes.
